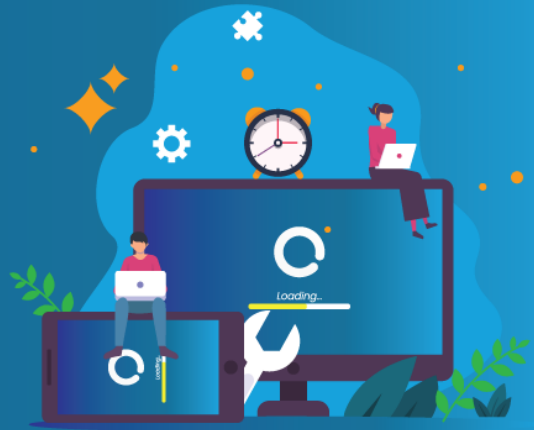

TIMS 25.3 New Feature Highlights

Roster – Timesheet Approval Functionality

Timesheets now have a status associated with assisting with the Timesheet Approval process, and to enable Timesheets locking. This feature will prevent 'Approved' Timesheets entries from being overwritten mistakenly.

Without the correct Security Access User will not be able to change Timesheet statuses.

TIMS 25.3 Enhancements to Existing Features

Operations Screen

The following improvements have been made to the existing Operations Screen.

- The Shift Sheet for unallocated work in its entirety can now be viewed
- Better Shift Sheet display refresh when changes are made
- Non-timetable lines can be deleted from the Shift Sheet
- Added ability to change Arrive Date on lines to enable Sign Offs after midnight
- Improved display of information on Shift Sheet when a Performance Monitor event is created
- Re-design of fonts and colours for the Shift Sheet to enhance readability
- The Shift Sheet can now be displayed by doubling clicking Employees, Despatches, Open work
- An additional option has been added to sort the Employee Column by Next Sign Off/Break
- An additional option has been added to sort the Despatch Column by Run
- Run # has been added to the Despatch cells in the Despatch Column

Yard Manager Plus

Yard Manager Plus now fully respects Defect Quarantine levels, along with location in the Yard when it impacts vehicle availability.

- When a vehicle that is considered Quarantined, or is parked in a Stop Slot, the Despatch list will display no Despatches
- When a Despatch is selected, any vehicle that is considered Quarantined or is parked in a Stop Slot will be hidden

Web Driver Terminal

The following functionality has been added to the Web Driver Terminal.

- After Sign Off allow Volunteerinf for the next 7 days

System Tweaks and Fixes

System

- Fixed an issue with User Preferences are not saved in the database.
- Improvements have been made to the way TIMS reconnects after losing connection to the database.

Roster

- Fixed an error that occurs when removing work from a driver that does not belong to the Business Unit, when they have work that belongs to their home Business Unit.
- Fixed an issue with the Load Shifts button on the Scratchpad not working.
- Fixed an issue where it wasn't possible to remove an Allowance from a Timesheet line.
- Fixed an issue where resizing columns in the Shift Book Details tab was not working.
- Fixed an issue where exiting the Timesheets window using 'X' and selecting 'No' don't save, was saving the data.
- An allowance entered in Timesheets on a line with no hours is no longer possible.

Day of Operations

- Fixed an issue where Auto Despatch was also allocating vehicles the day after.
- Fixed an issue where the Roster Type mismatch warning was not showing for allocation to 2nd part of a Shift.
- Only one purple highlighted cell will now be visible.
- Allocating a vehicle to a Despatch whilst that Shift Sheet is open will now automatically update the Shift Sheet.
- Change a Shift Sheet line type to Note will immediately update the Shift Sheet accordingly.

Creditors

- Fixed an issue when credit notes are applied across multiple invoices, the GST was not being calculated correctly.

Inventory

- Fixed an issue with obsolete items being included in a Stocktake when they were explicitly excluded during Stocktake creation.
- Fixed an issue where suggested re-orders was causing an incorrect Legal Entity Code in the Purchase Orders.

Human Resources

- Fixed an issue with adding Training to an Employees record.

Workshop

- Fixed an issue with Fuel Loaders changing historical Odometer readings if the dates in the past were in the file.
- Fixed an issue with Workorders not posting due to an erroneous negative stock value.
- Fixed an issue where the VOR date and Reason were not being saved when VOR set in the Workshop Schedule.
- Fixed an issue in the Workshop Schedule where Workorder creation would not always display list of additional jobs.

- Fixed an issue with Workorders being created without a Workorder Number.

Purchase Orders

- Fixed an issue where the Quantity entered was limited 2 decimal places.
- Fixed an issue where if a specific set of actions are undertaken, non-posted Purchase Orders could be deleted.

Payroll

- Fixed an issue with opening Transactions after a Transaction has been opened and closed by clicking Ok.
- Fixed an issue where fortnightly hours were not being capped if the week ended with a Leave Day Type.
- Fixed an issue with Superannuation for Under 18s not be calculated correctly.
- Quarterly Superannuation cap is now based on Envelope Date, not Pay Period Date.
- Fixed an issue where posting a Termination transaction was not removing the employee Active Flag.
- Fixed an issue where it was possible to post Payroll transaction to inactive accounts.
- Unallocated employees now no longer show in the Payroll Transactions table.
- Fixed an issue where the Award was not changing when more than one pay change for the Award exists.

TIMS Tablet

- Fixed a server error when retrieving documents from the server to the Tablet.

Charter

- Fixed an issue with opening a Charter Trip from the Charter Calendar, without opening the Charter first.
- Fixed an issue when Supervisor Employee Types are used in the Charter Allocation screen.
- Fixed an issue with Fuel Levy recalculates causing an error.
- Fixed an issue with Trip Notes not being displayed in the Charter Allocation screen.
- Fixed an issue where terminated employees would display in the Driver list in the Charter Allocation screen.
- Fixed an issue in the Charter Allocation screen where changes to the itinerary times were not being saved.
- Fixed an issue where copied Charters could be saved without Debtor information.
- Fixed an issue where copied Trips using 'Copy with New Date' did copy all bus lines.
- Fixed an issue where deleting additional Billing Lines would save the deletion prior to the Charter being saved. This didn't allow a User to cancel the action.
- Fixed an issue where changing a Trip from Cancelled would create extra bus lines in the Billing section.
